ELIGIBILITY: The CityWide Bail Bonds Halloween Costume Photo Contest as further described herein (the "Contest"), or The Sponsor CityWide Bail Bonds described herein (collectively, "Sponsor") is open only to legal residents of California, 18 years of age or older at time of entry.

Eligible Contestants must have a valid e-mail address and submit their photos through the CityWide website. Only 1 entry per family, person, email address, per household is allowed, so make it count!

Voting: Sponsor will select the winners.

CONDITIONS AND METHOD OF ENTRY: By entering this Contest you are granting Sponsor the right to upload photos submitted through this process to its Social Media and Web Pages, using your name, and city of residence. As conditions of entry into this Contest, and by uploading and entering a photo, each entrant warrants and represents that his or her photo complies with the Official Rules, Terms and Conditions. Sponsor has final approval of any language or content that appears on its Social Media pages and web site and may not promote or endorse third-party products, services, trademarked or registered articles, or language, items or content deemed inappropriate or offensive by Sponsor in its sole discretion, and such images may be deemed inadmissible and corresponding entries may be disqualified. Your photo entry must be submitted electronically on our website.

CONTEST PERIOD: Online entries can be uploaded starting 8:00 am Pacific Standard Time on October 4th, 2023. Deadline for submitting entries is 11:59 pm Pacific Standard Time on November 1st, 2023. Winners will be announced on or before November 13, 2023.

CLAIMING PRIZES/RELEASES: Prize will be awarded provided a sufficient number of eligible entries are received and properly claimed. Eligibility, age, and claims made by Prize Winners are subject to verification. Prize(s) will be sent to verified Winner(s) by pickup at our office, by mail or hand delivered.

PLEASE INCLUDE A CAPTION: A caption is requested to accompany your photograph, giving the circumstances in which it was obtained, and the thought/reason behind the image. Technical details are not required.

ENTRIES ARE MODERATED: Sponsor has the right to moderate all entries and disapprove your submission for any reason. All submissions will be subject to approval before they are posted publicly.

No Photoshop - No Photo Illustration - No Extensive Retouching - No Graphic Filters: These should be digital images from your Smartphone or digital camera.

Acceptable adjustments: Levels, brightness, contrast, curves, exposure, desaturate, etc.

Unacceptable extensive retouching - examples: Recoloring skin, photoshopping additional elements into photos, distorting, skewing, rotating, scaling, warping, perspective changing, or applying filters with graphic/animated elements that change/fake your image (e.g. Snapchat / Instagram / Facebook / TikTok / etc.).

Winners will be announced on our social media pages and contacted through the email provided. If no response is received after 10 business days, the winner(s) will forfeit all rights to the prize.

PRIZES AND WINNING PHOTOS: Judges will select (4) Prize Winners. Distribution of the prizes are subject to verification of an affidavit of eligibility and a liability and publicity release by the winning entrants. No substitution of prizes is offered, except at the sole discretion of Sponsor. Prizes are nontransferable. All winners are solely responsible for any state and federal taxes on his/her Prize. Only one Prize will be awarded per photo entry per person per household. Prize Winners are solely responsible for all federal, state and local taxes on prize, and all other expenses, costs or fees associated with the acceptance and/or use of any prize are the sole responsibility of the winner.
